**Bedford & County Athletic Club Membership Conditions of use of the Stadium Facilities**  
**(Only applies to membership categories that include the cost of a stadium pass)**

1. A stadium pass supplied through membership of Bedford & County AC (the Club) entitles you to use the outdoor track and other ancillary areas of Bedford International Athletic Stadium e.g. changing rooms, car park and social areas
2. Membership is not transferable.
3. When using stadium facilities, stadium cards must be produced on request by either the Stadium staff or Club officials. Failure to produce a valid card will result in you being charged the standard Stadium rate.
4. A charge of £5 (at time of writing) will be charged by the stadium to replace lost swipe cards.
5. A stadium pass supplied through membership of the Club entitles you to access the Stadium during Club sessions. The only exceptions are during outdoor events (dates can be obtained from Stadium Reception) and at the discretion of the Stadium management
6. In addition, a stadium pass entitles the holder to "casual use" at any time when the stadium is not booked out to others, over and above the entitlement as a club member (subject to normal conditions of use).
7. The Club cannot be held liable for any unexpected non-availability of the facilities and will not refund partial membership fees in this event
8. During the winter, floodlights/indoor track lights will only be in operation during club sessions or upon prior approval by the Stadium management and in conjunction with the Club committee.
9. During major events, Club members are not entitled to use the facilities unless paying to attend an event.

**JUNIOR MEMBERS' CHARTER (For all members under 18 years of age)**

**As a regular member of Bedford & County Athletic Club Limited (the "Club"), utilising and benefiting from the Club's coaching and other resources,**  
**I will:**

1. Respect and adhere to this Charter, and the rules and policies of the Club.
2. Understand that athletics is a competitive sport, both individual and team based, and the willingness to compete is a key ingredient in my development and I undertake to compete for the Club as and when I am reasonably requested to by my coach or team manager.
3. Maintain a constructive approach to training and demonstrate a loyalty to my coach who is giving his/her time voluntarily to help me improve.
4. Adhere to an appropriate standard of behaviour in the reasonable opinion of the Club when training or at competitions.
5. Ensure that I am properly equipped for training, as advised by my coach, particularly as far as suitable clothing is concerned on cold and wet winter nights.
6. Respect myself, other athletes, coaches, helpers and any other people attending the Club at all times.
7. Adopt and demonstrate a positive attitude and work ethic in my athletic training and competition.
8. Volunteer to help in whatever way is appropriate when asked by the Club.
9. Strive to improve, learn from setbacks and possible failures, and forge ahead to seek success.

**I understand that the Club has the right to withdraw its coaching services and / or decline or withdraw my membership to the Club if, in the reasonable view of the Club's Executive Committee (based on information from the relevant coaches), I do not adhere to this charter or the rules and policies of the Club**

**Data Protection & Privacy**

When you become a member of or renew your membership with Bedford & County AC you will automatically be registered as a member of England Athletics (except under 11s). We will provide England Athletics with your personal data which they will use to enable access to an online portal for you (called myAthletics). England Athletics will contact you to invite you to sign into and update your MyAthletics portal (which, amongst other things, allows you to set and amend your privacy settings). If you have any
